Hastings County Community and Human Services staff completed a Community Investment Review which was approved by Community and Human Services Committee and County Council in September 2022.

The Investment Review resulted in a new and simplified application process for funding. A standard application has been developed to allow applicants the opportunity to detail and define their funding ask and the support service that will be provided along with detailing how it meets the vision of the HPP guidelines as well as the needs of the community it serves.

The Investment Review also identified service area priorities that Committee and Council approved as being key areas that funding should be directed too. The applications will be reviewed, scored and weighted based on how well they address the identified service priorities.

As most of you are likely aware the CHPI (Community Homelessness Prevention Initiative) has been replaced by the Homelessness Prevention Program, (HPP)

o HPP consolidates the Community Homelessness Prevention Initiative (CHPI), Home for Good and the Strong Communities Rent Supplement Program into one flexible program. The program consolidation responds to several findings and recommendations from the December 2021 Office of the Auditor General of Ontario (OAGO) Value for Money audit of homelessness programs, the recent Multi-Ministry Supportive Housing Initiative (MMSHI), housing engagement sessions with Service Managers in 2020-21 and program reviews of CHPI, HFG and SCRSP.

The HPP vision is to provide funding to support service managers in implementing a variety of flexible, local approaches to delivery of services and supports with three key goals (outcomes) preventing homelessness (people at risk of homelessness remain housed and have connections to supports and services), addressing homelessness (people who are homeless and chronically homeless obtain and retain housing and support services) and reducing chronic homelessness (reductions in chronic homelessness)

The HPP service categories are:

- Supportive Housing
- Community Outreach and Support Services
- Housing Assistance

Policy

Hastings County's policy regarding funding requests for financial assistance is as follows:

Requests will be considered based on the following criteria:

Assisting organizations in creating or maintaining new programs or projects which provide a benefit or service to Hastings County residents for example, but not limited to: serving the vulnerable population, social services agencies, homelessness, meal and food programs, civic, cultural, and sports organizations or events. Promoting infrastructure of municipal, provincial, or national significance which could be expected to bring service

to the above, or economic and/or public relations benefits to Hastings County.

An urgent or pressing event or natural disaster, i.e., fire, flood, earthquake, pandemic relief etc.

The organization must demonstrate that it is presently exploring or has fully explored, potential funding from other sources, from other levels of government, the private sector, memberships, donations, and fundraising activities.

Organizations seeking assistance must be incorporated or in the process of applying for incorporation as a non-profit organization and/or is a registered charity. For-profit organizations may be considered if program demonstrates proprietary or service sector expertise highlighted in Section C.

Organizations must demonstrate that they are seeking alternative sources of revenue on an ongoing basis to achieve self-sufficiency.

Grant applications must be submitted prior to **NOVEMBER 1** to be included in the following years' budget. Grant applications must be accompanied by a budget for the year in which the grant is applicable, outlining all other sources of revenue, and expected expenditures.

Funds requested are to be utilized to maintain existing or create new programs or projects within Hastings County. Confirmation of coverage for Insurance and WSIB will be required, and the County will need to be named as Additional Insured for funded agencies.
